

NOTICE OF ELECTION

Parliamentary Election For the KENILWORTH & SOUTHAM CONSTITUENCY

1. An Election is to be held for a Member of Parliament to serve Kenilworth & Southam constituency.
2. Forms of nomination for the Parliamentary Election may be obtained at Warwick District Council, Saltisford 1, Ansell Way, Warwick CV34 4UL from the Acting Returning Officer who will, at the request of an elector for any electoral area prepare a nomination paper for signature.
3. Nomination papers must be delivered to the Acting Returning Officer, Warwick District Council, Town Hall, Parade, Royal Leamington Spa, Warwickshire, CV32 4AT on any day after the date of this notice between the hours of 10 am and 4 pm but no later than **4pm on Friday, 7th June 2024** by appointment only. Appointments can be made by emailing elections@warwickdc.gov.uk
4. The £500 deposit can be made either by legal tender, by means of a banker's draft from a drawer which carries on the business as banker in the United Kingdom or, with the Acting Returning Officer's consent, in any other manner (including electronic transfer of funds)
5. If any election is contested the poll will take place on Thursday, 4th July 2024.
6. Applications to register to vote must reach the Electoral Registration Officer by 12 midnight on **Tuesday 18th June 2024**. Applications can be made online: www.gov.uk/register-to-vote
7. New applications for postal votes, amendments or cancellations of postal votes and amendments or cancellations of proxy votes must reach the Electoral Registration Officer, Warwick District Council, Town Hall, Parade, Royal Leamington Spa, Warwickshire, CV32 4AT or the Electoral Registration Officer, Stratford on Avon District Council, Elizabeth House, Church Street, Stratford upon Avon, CV37 6HX or the Electoral Registration Officer, Rugby Borough Council, Town Hall, Evreux Way, Rugby, CV21 2RR by 5 pm on **Wednesday, 19th June 2024**.
8. Applications for a Voter Authority Certificate or an Anonymous Elector's Document valid for this election must reach the Electoral Registration Officer by **5pm on Wednesday 26th June 2024**. Applications can be made online: www.gov.uk/apply-for-photo-id-voter-authority-certificate
